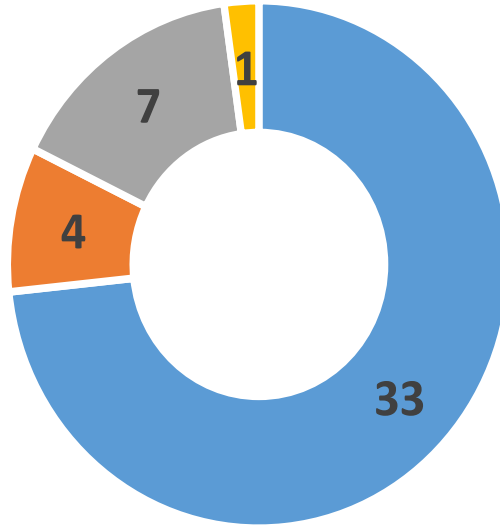

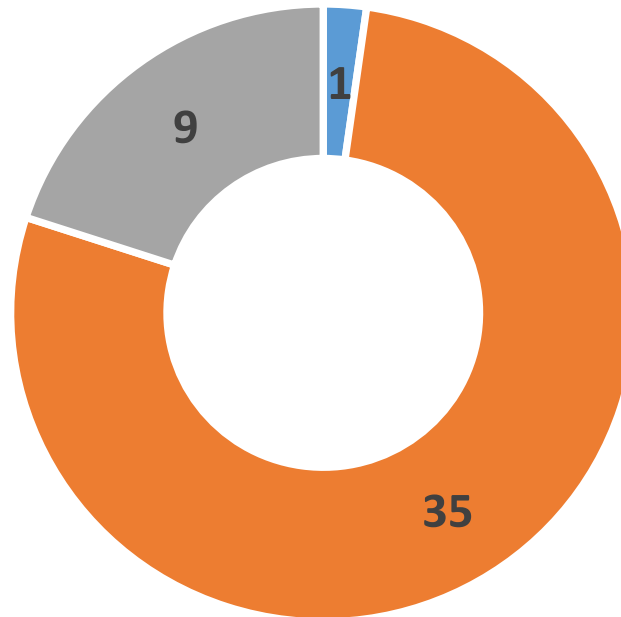

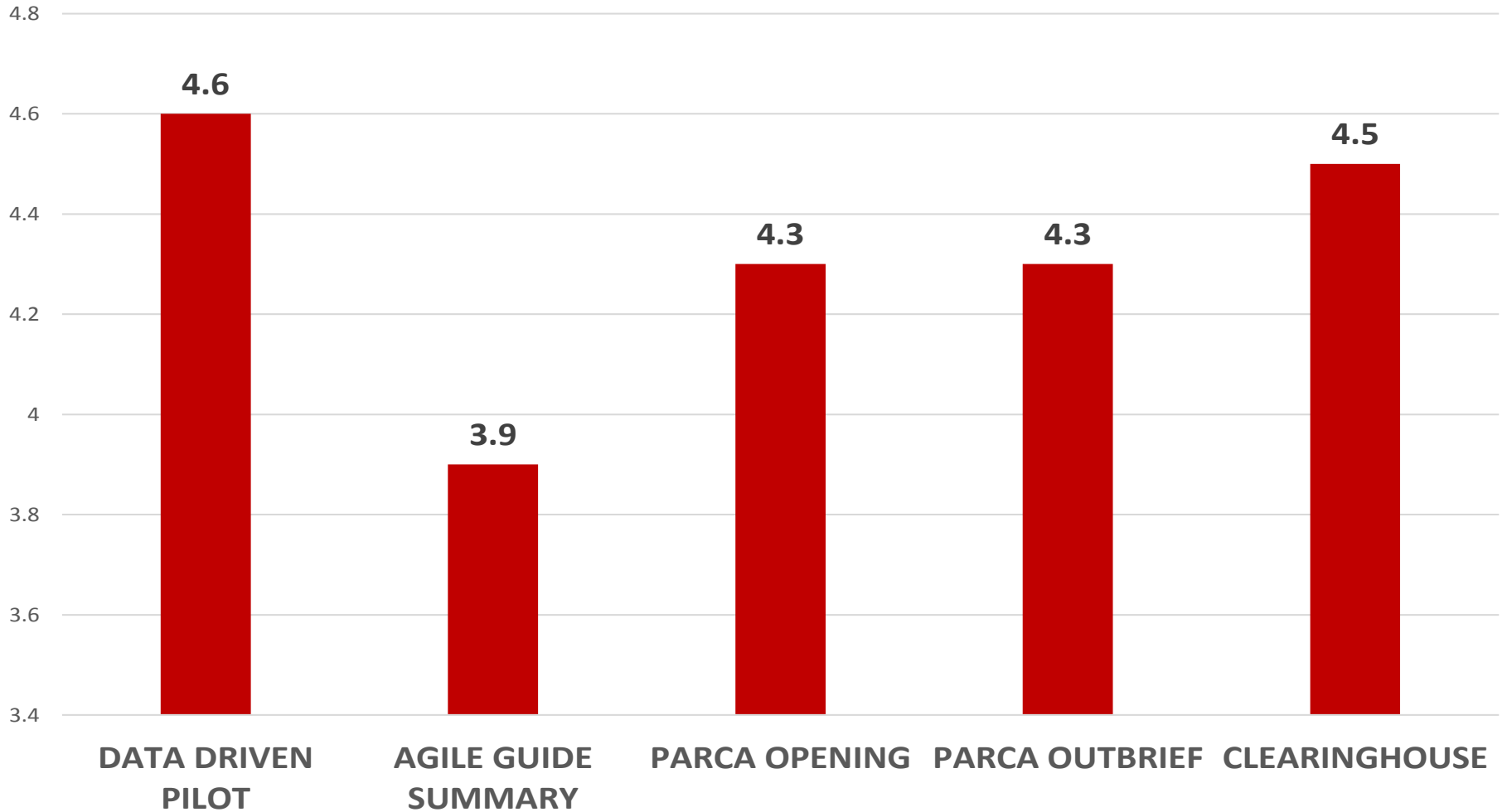
## Cost of Event

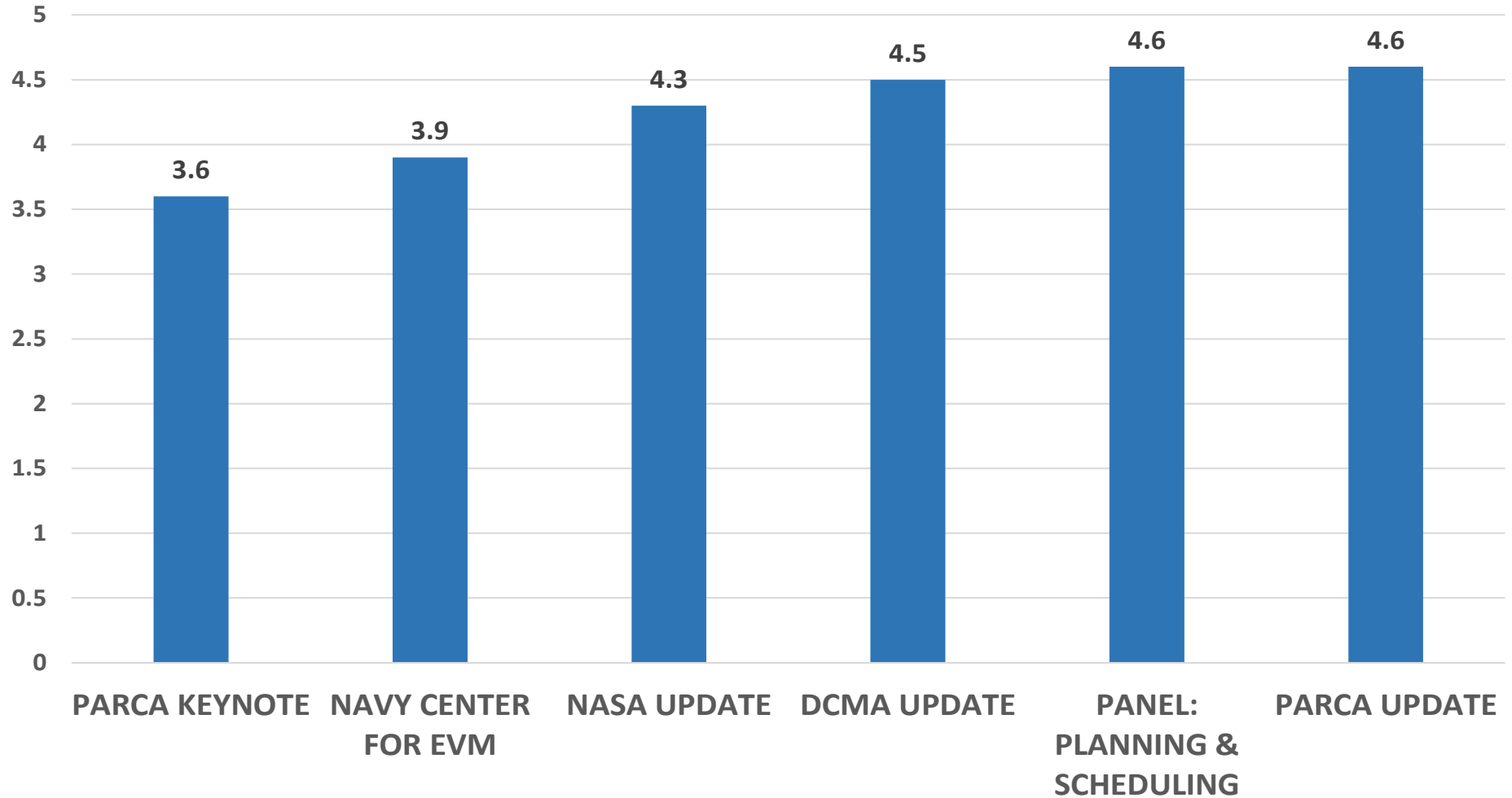

  - Broader application of expanded Format 7
    - Potential to eliminate Formats 1-4 XML and be utilized for DCMA Data Driven Surveillance
- **SASC NDAA bill mark up**

# IPMD Communications Initiative

  - Push frequent emails out to membership with info for meetings or volunteer needs
  - Collection and analysis of meeting feedback by Board
  - Rotating Working Groups present updates at the Board meetings
    - ✓ Intent is to keep the Working Groups results oriented and operating consistently, provide help when needed
  - Tie the Working Groups to sessions and tracks at EVM World and the IPM Workshop

- PARCA and DCMA participate in sessions at the strategic planning meetings
- Provide point papers to NDIA leadership
- Submit common industry or other issues to the PARCA EVM Interpretation and Issue Resolution web site
  - ✓ Examples: recommendations for updates to the EVMSIG, IPMR DID, IPMR Implementation Guide
- Submit articles on IPMD initiatives and Working Groups to CPM's *The Measurable News* and NDIA's *National Defense Magazine*
- Work closely with CPM to have strong IPMD presence at the IPM Workshop
