Updates to the Surveillance Guide



- Received 30 comments from five different companies/ agencies. Most comments were grammatical updates.
- Some of the changes include:
 - List of Abbreviations and Acronyms Added "Material Management and Accounting System (MMAS)".
 - Good discussion on the difference between a formal Compliance Evaluation Review (CER) and a Surveillance Review.
 - Section 2.2.1 Establishing a Surveillance Framework Added sources where one can find a surveillance framework such as the DCMA EVMS website and/or any civilian agency website.
 - Section 2.5 Learn from Results of Surveillance Reviews Added more description to an Annual Report as a matter of best practice.

Updates to the Surveillance Guide



- Some of the changes include (cont.):
 - Section 3.1.4 Notify the Project of the Review Notification of a surveillance review should be provided to the project manger and project team members to verify availability.
 - Section 3.1.5 Analyze Artifacts Prior to Project Interviews The Surveillance Team Lead is responsible to identify and document the test criteria.
 - Section 3.2 Conduct the Surveillance Review Added, if applicable, review the Data Driven Metrics for applicable guidelines.
 - Section 3.3 Deliver the Formal Surveillance Review Report and section 3.4 Root Cause and Corrective Actions by the Project
 Team changed the responsibility from "Surveillance Review Team" to "Surveillance Team Lead".

 - Appendix E Examples of Project Artifacts for Review:
 - Program Critical Path Method (CPM) documentation
 - Forward Pricing Rate Agreement (FPRA) / Forward Pricing Rate Proposal (FPRP)
 - List of major Subcontractors/Suppliers
 - Business System Letters of Approval from ACO or other cognizant authority, if applicable
 - Appendix F Surveillance Review Example Questions
 - If you have mitigated a risk, is it reflected in the schedule and traceable to your risk management plan?
