Founded in 1908, W.S. Darley & Co is a fourthgeneration family business, led by Paul and an executive team that has transformed this 111-year-old company into a world leader in the firefighting and defense industries.

Paul is a graduate of St. Ignatius College Prep in Chicago and he holds a BS Degree in Marketing and Finance from Marquette University. He earned his MBA from Northwestern University's Kellogg School of Management, where is a guest lecturer.

Paul has traveled to 80 countries in his 30-year tenure and has made over 500 industry speaking engagements. He is involved with numerous

charitable, business, and service organizations. He is a former Chairman of the Chicago Windy City Chapter of Young Presidents' Organization (YPO) and is a trustee for Dominican University.

He is a Past President of the Fire Apparatus Manufacturers Association (FAMA) and he also served on the Board of Directors of Fire & Emergency Manufacturers & Services Association (FEMSA). Paul Darley currently serves on the Board of the National Defense Industry Association (NDIA) for the Great Lakes Chapter.
